Motion was made by Easterling to approve Darlene Hopkins, Haskell County Extension Agent, as an adjunct faculty member for the 2018-2019 school year, seconded by Rogers. Motion passed with a vote: all for 0 against.

Motion was made by Rogers to approve the 2018-2019 Rule ISD Employee Handbook, seconded by Easterling. Motion passed with a vote: all for, 0 against.

Motion was made by Manske to approve Ken Frazier and Brad Jones as T-TESS administrators/appraisers, seconded by Easterling. Motion passed with a vote: all for, 0 against.

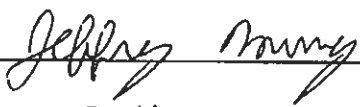
Mr. Frazier presented the principal report. Enrollment is currently at 119.

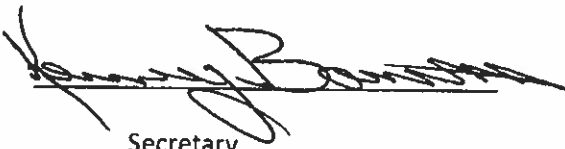
Mr. Jones presented the superintendent report.
